Students may attend make up classes at either studio location. Extended missed classes due to illness or injury with a doctor's note may be considered on an individual basis. All 10 week payments will be due on the following dates: August 8<sup>th</sup>, November 7<sup>th</sup>, January 30<sup>th</sup>, and a 10, 11 or 12 week payment April 2<sup>nd</sup>. The annual costume rental fee will be due with August payments. All exam fees will be due December 1<sup>st</sup>.

The member agrees to pay \$30.00 service charge for returned cheques. MDA reserves the right to cancel any class by refunding the initial fee and any unused dues. Late payment fees are \$10 +tax for 1<sup>st</sup> week and \$5 +tax for each additional week not paid. If a member chooses to pay fees using automatic payment, it is the member's responsibility to provide MDA with updated credit card information.
